


- The size of the site is 570m (200m * 2 & 85m * 2)
- Purchase of 230 Palisade Post Poles 2,4m (76 *76* 1,6mm + cap)
- 125 Palisade panels (2,5m * 1,8m)
- Welding of posts to panels
- Installation of the available sliding gate and Palisade Pieces

The Service provider will buy the palisade panels, post poles, weld them to the palisade pieces, install the gate and assist the available labour on site to do the job until complete.
