


- Purchase of 110 Palisade Post Poles 2,4m (76 *76* 1,6mm + cap)
- Welding of poles to the existing Palisade pieces
- Installation of the available gate and Palisade Pieces

The Service provider will buy the post poles, weld them to the palisade pieces, install the gate and assist the available labour on site to do the job until complete.
