Prepare and Paint Walls with 2 x Coats, Plascon Double Velvet (PVA) to match Existing paint. Surfaces shall be thoroughly sanded down with rough to medium grit paper before any paint is applied. Blistered or peeling paint shall be completely removed and cracks shall be opened, filled with suitable filler and finished smooth.

Paint to Previously Painted Wooden Doors. Surfaces shall be sanded down and smoothed before 2 x coats, Plascon High Gloss Enamel matching existing is applied.

Paint to Previously Painted Metal i.e. Door Frames.

Remove all loose and flaking paint, feather edges of tightly bonding paint before 2 x coats, Plascon High Gloss Enamel matching existing paint can be applied
