TERMS OF REFERENCE FOR THE APPOINTMENT OF A SERVICE PROVIDER TO CONDUCT A GEOGRAPHICAL INFORMATION SYSTEMS NEEDS ASSESSMENT FOR THE MHLONTLO LOCAL MUNICIPALITY

1. BACKGROUND

Increasing computing power and sophisticated telecommunications technology has made the development of distributed Spatial Information Systems a reality. The use of such a distributed environment provides a new and powerful means of gathering, processing and disseminating a vast array of spatial information products. However, having access to information has little value unless it is used in addressing socio-economic problems of the country. Various GIS databases exist in different spheres of government but the full potential has not been realized. GIS has not yet been fully integrated into service delivery, development planning and governance.

Mhlontlo Local Municipality has NO GIS currently. In view of this, the Municipality is looking to appoint a service provider that will do a thorough GIS needs assessment for the institution.

2. PROBLEM STATEMENT

Municipalities lack GIS capability in South Africa in general – only the metropolitan municipalities are well served in terms of GIS. Currently there is no coordinated effort to provide GIS support to municipalities. There are many role players that will have an input to the GIS support process. The responsibility to support municipalities in terms of GIS is not government's alone. Mhlontlo Local Municipality has no GIS capacity at all.

Mhlontlo Local Municipality faces considerable challenges. These include:

- Lack of existing GIS capacity
- Lack of computer hardware
- Poor IT/Network infrastructure
- Lack of useful spatial information at Mhlontlo Local Municipality (Cadastral, utilities etc)
- Lack of data verification mechanisms and processes
- Lack of integration of municipal systems (finance, engineering, corporate services, valuation roll etc)
- Lack of useful Land Use Management Scheme with symbology in colour and in GIS format and outdated or lack of zoning maps

3. AIMS AND OBJECTIVES

The purpose of this Terms Of Reference is to out line the scope for the service provider's proposal the proposal must include the following:

- A full assessment of the Mhlontlo Local Municipal GIS needs per department.
- Assess, collate and document readily available GIS data covering MLM
- To do a Gap Analysis between the needs expressed and data that is and is not available to support those needs
- To draw up a GIS Implementation Plan for MLM
- To initiate and support a GIS Steering Committee that will guide the GIS initiation and implementation process through regular meetings and interaction
- To recommend staffing requirements to support the model
- To strategize on how best to satisfy the GIS requirements of MLM considering GIS developments and initiatives of the District Municipality.
- To make recommendations on integration opportunities between GIS and the existing information systems at MLM, in particular the billing system and valuation role.

- To prepare a draft term of reference for implementation.

PROJECT DESCRIPTION

Through these Terms of Reference, the municipality seeks to appoint a service provider that will help to provide a complete needs assessment for the needs of the Municipality for a Geographic Information Systems .

PROJECT DURATION AND COST

It is expected that the project be completed in a period of **5** months effective from the date of appointment. The target dates for each milestone (as well as the associated deliverable) and the amount of financial compensation for the work done is scheduled under Table 1.

Due to the urgency of the project it is critical that timeframes are strictly adhered to. Financial penalties will be imposed for any delay or non-compliance with time and quality requirements.

SKILLS AND EXPERIENCE

Below is a summary of Mandatory requirements: Project leader must hold a tertiary qualification in GIS based Application Development which is recognized for registration in the category of GISc Professional by the Professional and Technical Surveyors' Act, 1984 as a Professional GISc Practitioner (a Copy of valid certificate and to be attached).

Skills and abilities required in the team to execute the project include the following:

- Understanding of the interrelationship amongst the following: social, economic, land use, transport and environmental issues;
- Geography and hands on GIS (at least at Technician Level);
- Project Management;
- Facilitation;
- Research, analytical, writing and communication skills;
- Strategic Planning

INFORMATION GATHERING

The successful Service Provider is expected to contact all the relevant GIS, Planning and required officials and units within the local and provincial spheres of government to obtain relevant information that is required for the project. Existing information on SDFs, IDPs, SDBIPs, ORGANOGRAM, and any other form which are available within the municipality will be made available to the successful service provider by the municipality.

In the light of the event that the service provider needs a letter to confirm the motive for requesting information from the different spheres of government or parastatals, the Municipality will provide the requested letter.

FINANCIAL PENALTIES

Financial penalties shall be imposed for agreed upon milestones, targets, and deadline not met without providing:

- Timely notification of such delays.
- Valid reasons for the delays.
- Supporting evidence that the delays were outside of the influence of the service provider.

Payments will be made only for work performed to the satisfaction of the Municipality. The Project Steering Committee will need to take a resolution concerning the work undertaken by the service provider. This resolution will then be reflected in the minutes of the meeting. The minutes will be submitted as part of the documentation required in order to process payment.

Financial penalties will be imposed if the outputs produced do not meet the agreed upon deliverables criteria as stipulated in the General Conditions of Contract.

A pricing schedule, **submitted on a separate sheet from the technical proposal for ease of evaluation.**

The pricing schedule should include the following:

- The names of the persons nominated to be used on the project;
- The number of hours allocated to each nominated person for the duration of the project;
- The hourly tariff applicable to each nominated person;
- All monetary amounts must be in South African Rand;

- Disbursements must be indicated separately and inclusive; and
- VAT must be included.

REPORTING AND ACCOUNTABILITY

During the execution of the project, the service provider must submit regular progress reports and attend meetings at intervals as determined by the project team or steering committee managing the service provider.

All information captured and or used to generate the outputs of the project remains the property of the municipality, and must be handed over in its totality when the project is closed. The municipality will retain copyright and all associated intellectual rights thereof. This document together with all agreements to be or reached during the course of the project become part of the contract. The information must be captured and provided in a digital format as agreed (in writing) between the service provider and the Municipality. This agreement must be reached and signed off together with the project plan before the project commences.

The project will be signed off by the municipality when:

- all the end products (refer to list) have been delivered and (***all deliverables per phase to be approved by the Project Manager***)

EVALUATION CRITERIA

This bid shall be evaluated in two stages. On first stage bids will be evaluated on functionality, second stage evaluation will be in accordance with 80/20 preference points system as stipulated below.

First Stage -Evaluation of Functionality

The evaluation of the functionality will be done individually by Members of Bid Evaluation Committee in accordance with the following functionality criteria and values.

All service providers who scored less than 70 out of 100 points for functionality will not be considered further.

ADDENDUM TO THE CONTRACT: POPIA OBLIGATION

1. PROTECTION OF PERSONAL INFORMATION

1.1. Processing limitations

It is recorded that, pursuant to its obligations under this Agreement, Service Provider will process Personal Information in connection with and for the purposes of the provision of the Services for or on behalf of Mhlontlo LM and will act as Mhlontlo LM's Operator for purposes of Protection of Personal Information Act (POPIA) no.4 of 2013. Unless required by law, Service Provider shall process the Personal Information only:

- 1.1.1. On behalf of Mhlontlo LM and in compliance with its instructions and this Agreement;
- 1.1.2. For the purposes connected with the provision of the Service Provider services or as specifically otherwise instructed or authorised by Mhlontlo LM in writing; and
- 1.1.3. Service Provider shall treat the Personal Information that comes to its knowledge or into its possession as confidential and shall not disclose it without the prior written consent of Mhlontlo LM.

1.2. Security measures

1.2.1. Service Provider warrants that it shall secure the integrity of the Personal Information in its possession or under its control by taking appropriate, reasonable technical and organisational measures to prevent:

- (a) Loss of, or damage to, or unauthorised destruction of the Personal Information; and
- (b) Unlawful access to or processing of the Personal Information.

1.2.2. Service Provider shall take reasonable measures to:

- (a) Identify all reasonable foreseeable internal and external risks to the Personal Information in its possession or under its control;

- (b) Establish and maintain appropriate safeguards against the risk identified;
- (c) Regularly verify that the safeguards are effectively implemented;
- (d) Ensure that the safeguards are continually updated in response to new risks or deficiencies in previously implemented safeguards; and
- (e) Shall notify Mhlontlo LM of the risks identified and the safeguards established and implemented from time to time.

1.2.3. Service Provider shall:

- (a) Have due regard to generally accepted information security practices and processes which may apply to it;
- (b) Comply with Mhlontlo LM's information security practices and procedures and applicable industry or professional rules and regulations, of which Mhlontlo LM undertakes to keep Service Provider informed from time to time; and
- (c) Within five (5) business days of a request from Mhlontlo LM, Service Provider shall provide to Mhlontlo LM a written explanation and full details of the appropriate technical and organisational measures taken by or on behalf of Service Provider to demonstrate and ensure compliance with this clause.

1.3. Service Provider's general obligations with regards to Personal Information

1.3.1. In addition to the other obligations set out in this clause, Service Provider shall:

- (a) Take reasonable steps to ensure the reliability of any of its employees who have access to the Personal Information;
- (b) Limit access to the Personal Information only to those employees who need to know to enable Service Provider to perform the services and ensure that employees used by Service Provider to provide the Services have undergone training in the care and handling of the Personal Information;
- (c) Deal promptly and properly with all reasonable inquiries from Mhlontlo LM relating to its Processing of the Personal Information and provide to Mhlontlo LM copies of the Personal Information in the format reasonably specified by Mhlontlo LM;

- (d) Promptly inform Mhlontlo LM of its inability to comply with Mhlontlo LM's instructions and this clause, in which case Mhlontlo LM is entitled to suspend the processing of Personal Information and/or terminate this Agreement;
- (e) Provide Mhlontlo LM with full co-operation and assistance in relation to any requests for access or correction or complaints made by Data Subjects; and
- (f) At the request of Mhlontlo LM or any regulatory body, submit its Personal Information Processing facilities for audit of the Processing activities covered by this Agreement.

1.4. Notifications

1.4.1. Service Provider must notify Mhlontlo LM in writing:

- (a) Within 1 (one) business day or otherwise as soon as reasonably possible if any Personal Information has been or may reasonably believe to have been accessed or acquired by an unauthorised person or if a breach has occurred with reference to its use of the Personal Information under this Agreement. The notification must provide sufficient information to allow affected Data Subjects to take measures against the potential consequences of the compromise, including, if known to Service Provider, the identity of the unauthorised person who may have accessed or acquired the Personal Information;
- (b) Within 3 (three) business days of receipt thereof, of any request for access to or correction of the Personal Information or complaints received by Service Provider relating to Mhlontlo LM's obligations in terms of POPIA and provide Mhlontlo LM with full details of such request or complaint; and
- (c) Promptly of any legally binding request for disclosure of Personal Information or any other notice or communication which relates to the Processing of the Personal Information from any supervisory or governmental body.

1.5. Return or destruction of Personal Information

Upon termination of this Agreement or upon request by Mhlontlo LM, Service Provider shall return any material containing, pertaining or relating to the Personal Information disclosed pursuant to this Agreement to Mhlontlo LM. Alternatively, Service Provider shall, at the instance of Mhlontlo LM, destroy such material and shall certify to Mhlontlo LM that it has done so, unless the law prohibits Service Provider from doing so. In applying this destruction alternative, the Service Provider shall provide Mhlontlo LM with the Certificate of Destruction to confirm that the destruction was done in a manner that the Personal Information cannot be reconstructed to its original format. In that case, Service Provider warrants that it will guarantee the confidentiality of the Personal Information and will not actively process the Personal Information any further.

1.6. Warranties

Service Provider warrants that in addition to the warranties stated in the rest of this Agreement, it shall comply with all regulatory and statutory requirements which impact on or relate to Service Provider and the Services, including, but not limited to, POPIA.

1.7. Indemnities

Service Provider hereby indemnifies and holds harmless Mhlontlo LM from any and all penalties, claims, loss or damage arising from any claim or action brought against Mhlontlo LM and arising from or due to Service Provider's breach of its information protection obligations set out in this clause.

1.8. Ownership of Information

- 1.8.1.** Service Provider acknowledges and agrees that Mhlontlo LM retains all right, title and interest in and to the Personal Information.
- 1.8.2.** Service Provider shall not possess or assert any lien or other right against or to such Personal Information and no such Personal Information shall be sold, assigned, leased or otherwise disposed of to third parties by Service Provider or commercially exploited by or on behalf of Service Provider or its employees
