1. INTRODUCTION

Kumkani Mhlontlo Local municipality is one of local municipalities in the OR Tambo District Municipality with two licenced landfill sites. A decision was taken to use the Tsolo a waste transfer station. The proposed facility will serve as recycling and sorting facility as well as landfill airspace

2. BACKGROUND

The municipality requires a service provider for the design and construction of a new waste transfer station in Tsolo magisterial district. A Project Brief has been detailed below, ANNEXTURE A

3. INVITATION FOR PROPOSAL

Proposals are hereby invited for a Contractor/ Service Provider for the implementation of a turnkey project (plan, design, construct, supervise and closeout) of waste transfer on the designated site.

4. PROPOSAL SPECIFICATION

All proposals are to be submitted in a format specified in this RFP.

Scope of Services

The Contractor/ Service Provider shall provide the services related to the requirements and scope of work as described, including but not limited to the following:

4.1.1 Requirements

- The Contractor/ Service Provider must define their methodology.
- The Contractor / Service Provider must submit monthly progress reports to municipality.
- The progress and quality of the Planning, Design, Construction, Supervision and Close out of the project may be independently monitored by the municipality and/ or its nominated agent. The Contractor/ Service Provider will be required to permit access to, cooperate with and respond to such activities.
- The Contractor / Service Provider must provide the municipality with a construction guarantee.
- The Contractor/ Service Provider shall ensure that all works comply with the applicable law, including Municipal Finance Management Act (MFMA), Construction Industry Development Board (CIDB) regulations, local authority requirements, the Occupational Health and Safety Act (OHSA), National Environmental Management Act (NEMA) and the National Building Standards Act.
- The Contractor / Service Provider must liaise, co-operate and provide the necessary information with all project stakeholders in all work stages.

4.1.2 Planning

- Convene a project team;
- Inspect the site and advise on the necessary surveys, analysis, tests and site or other investigations, where such information will be required.
- Confirm the services and scope of work required;
- Develop a project program and execution plan; and
- Prepare a scoping report.

4.1.3 Design, Implementation and Site Monitoring

- Liaise, cooperate and share information with project sponsors and other parties

contracted by the client throughout the different stages of the project and on request.

- Preparation of preliminary design report.
- Incorporate technology /equipment from the sponsor as part of the design where applicable.
- Preparation of preliminary budget and value engineering.
- Preparation of detail and final design.
- Submission of drawings to local authority and ensuring approval where applicable.
- Preparation of working drawings.
- Preparation of final cost estimate (Budget);
- Compilation of contract documents (Contract information, Bill of Quantities, Contract specification, etc.);

4.2 Competencies of service provider

- Good knowledge of Building Construction of relevance to the sheds structure as evidenced by:
- Track record of use of innovative building technologies and materials.
- Track record of fast-tracking buildings; and
- Proven experience in application of green building concepts, processes and practices.
- The Contractor/ Service Provider must have the necessary/ relevant construction experience and must be able to put together a consortium of built environment professionals and include the following services:
- Architecture, civil & structural engineering, electrical and mechanical engineering (including fire services), landscaping, occupational health & safety (OHS) and green building and the environment.
- Good knowledge of all relevant national, provincial and municipal legislation, policies, strategies, norms and standards.
- Proven project management skills.
- Ability to produce systematic, comprehensive and informative documents and reports on an ongoing basis.

4.4 Credentials

4.4.3 The Competent Person who will take overall responsibility, lead and oversee the design, engineering and compliance, must be Professional Engineer in the built environment registered with the Engineering Council of South Africa (ECSA) or the South Africa Council for the Architectural Profession (SACAP). The competent person must provide a letter from a duly authorised representative acknowledging this role and provide proof of the applicable professional indemnity insurance.

4.4.4 The construction works must be the responsibility of the Contractor with a track record of relevant construction experience, CIDB grade 2GB , traceable via the CIDB. A letter of support from a duly authorised representative of the Contractor acknowledging this role is required.

4.5 Methodology

The proposal must provide a statement on methodology which the successful bidder will implement. The scope of work is to be identified. Roles and responsibilities are to be allocated with reference to key personnel. Planning, Design, Construction, Supervision and Close out shall be separately described. The methodology must cover, inter alia, plausible project plans to meet time, costs and quality specifications, and shall include.

ADDENDUM TO THE CONTRACT: SUPPLY AND INSTALL NEW PALISADE FENCING

1. PROTECTION OF PERSONAL INFORMATION

1.1. Processing limitations

It is recorded that, pursuant to its obligations under this Agreement, Service Provider will process Personal Information in connection with and for the purposes of the provision of the Services for or on behalf of Kumnkani Mhlontlo LM and will act as Kumnkani Mhlontlo LM's Operator for purposes of Protection of Personal Information Act (POPIA) no.4 of 2013. Unless required by law, Service Provider shall process the Personal Information only:

- 1.1.1.** On behalf of Kumnkani Mhlontlo LM and in compliance with its instructions and this Agreement;
- 1.1.2.** For the purposes connected with the provision of the Service Provider services or as specifically otherwise instructed or authorised by Kumnkani Mhlontlo LM in writing; and
- 1.1.3.** Service Provider shall treat the Personal Information that comes to its knowledge or into its possession as confidential and shall not disclose it without the prior written consent of Kumnkani Mhlontlo LM.

1.2. Security measures

1.2.1. Service Provider warrants that it shall secure the integrity of the Personal Information in its possession or under its control by taking appropriate, reasonable technical and organisational measures to prevent:

- (a) Loss of, or damage to, or unauthorised destruction of the Personal Information; and
- (b) Unlawful access to or processing of the Personal Information.

1.2.2. Service Provider shall take reasonable measures to:

- (a) Identify all reasonable foreseeable internal and external risks to the Personal Information in its possession or under its control;
- (b) Establish and maintain appropriate safeguards against the risk identified;
- (c) Regularly verify that the safeguards are effectively implemented;
- (d) Ensure that the safeguards are continually updated in response to new risks or deficiencies in previously implemented safeguards; and
- (e) Shall notify Kumnkani Mhlontlo LM of the risks identified and the safeguards established and implemented from time to time.

1.2.3. Service Provider shall:

- (a) Have due regard to generally accepted information security practices and processes which may apply to it;
- (b) Comply with Kumnkani Mhlontlo LM's information security practices and procedures and applicable industry or professional rules and regulations, of which Kumnkani Mhlontlo LM undertakes to keep Service Provider informed from time to time; and
- (c) Within five (5) business days of a request from Kumnkani Mhlontlo LM, Service Provider shall provide to Kumnkani Mhlontlo LM a written explanation and full details of the appropriate technical and organisational measures taken by or on behalf of Service Provider to demonstrate and ensure compliance with this clause.

1.3. Service Provider's general obligations with regards to Personal Information

1.3.1. In addition to the other obligations set out in this clause, Service Provider shall:

- (a) Take reasonable steps to ensure the reliability of any of its employees who have access to the Personal Information;
- (b) Limit access to the Personal Information only to those employees who need to know to enable Service Provider to perform the services and ensure that employees used by Service Provider to provide the Services have undergone training in the care and handling of the Personal Information;
- (c) Deal promptly and properly with all reasonable inquiries from Kumnkani Mhlontlo LM relating to its Processing of the Personal Information and provide to Kumnkani Mhlontlo LM copies of the Personal Information in the format reasonably specified by Kumnkani Mhlontlo LM;
- (d) Promptly inform Kumnkani Mhlontlo LM of its inability to comply with Kumnkani Mhlontlo LM's instructions and this clause, in which case Kumnkani Mhlontlo LM is entitled to suspend the processing of Personal Information and/or terminate this Agreement;
- (e) Provide Kumnkani Mhlontlo LM with full co-operation and assistance in relation to any requests for access or correction or complaints made by Data Subjects; and
- (f) At the request of Kumnkani Mhlontlo LM or any regulatory body, submit its Personal Information Processing facilities for audit of the Processing activities covered by this Agreement.

1.4. Notifications

1.4.1. Service Provider must notify Kumnkani Mhlontlo LM in writing:

- (a) Within 1 (one) business day or otherwise as soon as reasonably possible if any Personal Information has been or may reasonably believe to have been accessed or acquired by an unauthorised person or if a breach has occurred with reference to its use of the Personal Information under this Agreement. The notification must provide sufficient information to allow affected Data Subjects to take measures against the potential consequences of the compromise, including, if known to Service Provider, the identity of the unauthorised person who may have accessed or acquired the Personal Information;
- (b) Within 3 (three) business days of receipt thereof, of any request for access to or correction of the Personal Information or complaints received by Service Provider

- relating to Kumnkani Mhlontlo LM's obligations in terms of POPIA and provide Kumnkani Mhlontlo LM with full details of such request or complaint; and
- (c) Promptly of any legally binding request for disclosure of Personal Information or any other notice or communication which relates to the Processing of the Personal Information from any supervisory or governmental body.

1.5. Return or destruction of Personal Information

Upon termination of this Agreement or upon request by Kumnkani Mhlontlo LM, Service Provider shall return any material containing, pertaining or relating to the Personal Information disclosed pursuant to this Agreement to Kumnkani Mhlontlo LM. Alternatively, Service Provider shall, at the instance of Kumnkani Mhlontlo LM, destroy such material and shall certify to Kumnkani Mhlontlo LM that it has done so, unless the law prohibits Service Provider from doing so. In applying this destruction alternative, the Service Provider shall provide Kumnkani Mhlontlo LM with the Certificate of Destruction to confirm that the destruction was done in a manner that the Personal Information cannot be reconstructed to its original format. In that case, Service Provider warrants that it will guarantee the confidentiality of the Personal Information and will not actively process the Personal Information any further.

1.6. Warranties

Service Provider warrants that in addition to the warranties stated in the rest of this Agreement, it shall comply with all regulatory and statutory requirements which impact on or relate to Service Provider and the Services, including, but not limited to, POPIA.

1.7. Indemnities

Service Provider hereby indemnifies and holds harmless Kumnkani Mhlontlo LM from any and all penalties, claims, loss or damage arising from any claim or action brought against Kumnkani Mhlontlo LM and arising from or due to Service Provider's breach of its information protection obligations set out in this clause.

1.8. Ownership of Information

1.8.1. Service Provider acknowledges and agrees that Kumnkani Mhlontlo LM retains all right, title and interest in and to the Personal Information.

1.8.2.
