SECTION 2: PROCEDURE FOR SUBMISSION OF QUOTATIONS

1. No quotation will be considered unless submitted on this RFQ document.
2. Telephonic, telegraphic, facsimile or emailed submissions, or any other electronic submissions, will not be accepted, unless indicated otherwise in this document.
3. Submissions must be marked with the RFQ description and reference number, sealed and deposited in the tender box on or before the closing date and time for submissions.
4. Submissions deposited in the tender box after the closing time or closing date will be considered to be late.
5. Late submissions will not be accepted, and where practicable, shall be returned unopened to the bidder.
6. Mhlontlo Local Municipality accepts no responsibility for ensuring that RFQ submissions are placed in the correct box, and submissions placed in the incorrect box will not be accepted.
7. Bidders are entitled to submit one quotation only, either as a single tendering entity or as a member of a joint venture or consortium.
8. Bidders are responsible for all costs incurred in the preparation and submission of their quotation.
9. The RFQ submission must be signed by a person or persons duly authorised to do so.
10. Once the quotation is awarded, all purchases will be made through an official Mhlontlo Local Municipality purchase order.
11. No goods or services must be delivered or provided before an official order has been sent to, and accepted by the successful bidder.

SECTION 3: TEST FOR RESPONSIVENESS

Invalid submissions

Quotations shall be invalid if:

1. The submission is not completed in non-erasable ink.
2. The bidder, if he or she is a natural person, is in the service of the state, or if not a natural person, a director, manager, principal shareholder or stakeholder of the bidder is in the service of the state.
3. The bidder is listed on the National Treasury Register of Tender Defaulters and / or List of Restricted Suppliers and is restricted from doing business with the public sector.
4. The bidder has been restricted from doing business with Mhlontlo Local Municipality in terms of its supply chain management policy and procedures.

Non-responsive submissions

Quotations will be declared as non-responsive and eliminated from further evaluation in the following instances:

1. The submission does not comply with the mandatory requirements of the RFQ, if any, including any minimum evaluation criteria.
2. The bidder's tax matters are found not to be in order upon verification by the Municipality on CSD, and the bidder fails to ensure that its tax matters are in order within such timeframe as may be granted by the municipality.
3. Where the bidder is not registered on CSD.
4. Where the bidder is not registered on the municipal supplier database, or does not meet the listing criteria for accredited suppliers specified in the municipality's SCM Policy, and does not register on the database or meet the listing criteria within such timeframe as may be granted by the municipality.

SECTION 5: SPECIFICATIONS AND EVALUATION CRITERIA

1. SPECIFICATION FOR SERVICE PROVIDER TO REVIEW ANNUAL FINANCIAL STATEMENT AND ANNUAL PERFORMANCE REPORT.

BACKGROUND

The MFMA section 126 prescribes that all municipalities must prepare and submit their Annual financial statement (AFS) to the Auditor General. The said AFS must be credible, reliable, complete, valid and free from material errors. Municipalities operate under a delegation of authority from the Minister of Co-operative governance and Traditional Affairs.

SPECIFICATIONS

i. Review of Annual Financial Statements

The scope of work relating to the Draft AFS prepared by Management must focus on the following key areas:

- Review of the overall presentation and disclosure of the draft AFS to ensure compliance with relevant GRAP standards;
- Verification that notes and disclosures align with applicable reporting guidelines and supporting schedules.
- Assurance that the draft AFS is appropriately presented and disclosed in line with GRAP requirements.
- Comparative figures in the AFS agrees to prior year audited AFS, Annual report and including accounting adjustment required.
- That the AFS are correctly casted and cross-casted.
- That the notes to the AFS are properly numbered and correctly linked to the AFS
- The notes to the AFS support the balances in the Statement of Financial Performance, Statement of Financial Position and Cash Flow Statements amongst other.
- Adequacy of information contained in the audit file (TB, lead Schedule and General Ledger).
- The completeness of the draft AFS (spelling and grammar)
- That the AFS agrees to the fixed asset register, debtors age analysis and other supporting documentation contained in the lead schedules.
- Ensure that all the financial information is recorded.
- Obtain trial balances and determine whether it is aligned to the general ledger and the financial statements.
- Ensure that the accounting policies and policies are in place, comply with GRAP standards and are applied appropriately.
- Ensure that the accounting policies are applied consistently and/or that the disclosure notes have been made where applicable.
- Obtain explanations from management for any unusual fluctuation or inconsistencies in the financial statements
- Ensure that all applicable disclosure notes are included in the annual financial statements.
- Ensure Full GRAP compliant AFS
- Ensure completeness of MFMA 68 disclosures
- Review the updated Commitments register to WIP

- Review all componentization made
- Review all lease transactions to billing reports and lease register
- Ensure the audit file for the entire audit file is complete, all class of transactions and account balances are supported by schedules or reconciliations

ii. Review of Prior Year Audit Findings

The service provider will be expected to:

- Conduct a detailed review of audit findings raised during the 2023/24 audit cycle;
- Assess the current status of each finding based on the audit action plan
- Evaluate the adequacy and effectiveness of management's remedial actions;
- Identify unresolved issues or repeat findings, including underlying causes;
- Provide independent commentary on the progress made and any areas of concern or risk of non-compliance.

iii. Review of Annual Performance Report

The appointed service provider must:

- Review Draft Annual Performance Report for the principles of SMARTNESS.
- Review Draft Annual Performance Report against supporting information.
- Review Draft Annual Performance Report against SDBIP and IDP.

iv. Reporting and recommendations

The appointed service provider must:

- Submit a detailed report to the Audit Committee summarizing all findings and observations.
- Provide practical, prioritized recommendations to address recurring or unresolved audit findings.
- Attend at least one Audit Committee meeting (or more, if agreed) to present the findings and respond to queries.

Note:

1. All prices quoted must include VAT, if the bidder is a registered VAT vendor.
2. Prices quoted must include delivery costs and goods must be delivered to the address provided.
3. All prices submitted must be firm. Firm prices are deemed to be fixed prices, which are only subject to statutory changes.

SECTION 7: CONDITIONS OF CONTRACT

The contract between the municipality and the appointed bidder will be administered in accordance with the General Conditions of Contract 2010 as issued by National Treasury. A copy of the General Conditions of Contract may be obtained from the National Treasury website – www.treasury.gov.za

1.1. PROTECTION OF PERSONAL INFORMATION: SERVICE PROVIDER TO REVIEW ANNUAL FINANCIAL STATEMENT AND ANNUAL PERFORMANCE REPORT.

1.2. *Processing limitations*

It is recorded that, pursuant to its obligations under this Agreement, Service Provider will process Personal Information in connection with and for the purposes of the provision of the Services for or on behalf of Kumkani Mhlontlo Local Municipality and will act as Kumkani Mhlontlo Local Municipality Operator for purposes of Protection of Personal Information Act (POPIA) no.4 of 2013. Unless required by law, Service Provider shall process the Personal Information only:

- 1.2.1.** On behalf of Kumkani Mhlontlo Local Municipality and in compliance with its instructions and this Agreement;
- 1.2.2.** For the purposes connected with the provision of the Service Provider services or as specifically otherwise instructed or authorised by Kumkani Mhlontlo Local Municipality in writing; and
- 1.2.3.** Service Provider shall treat the Personal Information that comes to its knowledge or into its possession as confidential and shall not disclose it without the prior written consent of Kumkani Mhlontlo Local Municipality.

1.3. *Security measures*

- 1.3.1.** Service Provider warrants that it shall secure the integrity of the Personal Information in its possession or under its control by taking appropriate, reasonable technical and organisational measures to prevent:
 - (a) Loss of, or damage to, or unauthorised destruction of the Personal Information; and
 - (b) Unlawful access to or processing of the Personal Information.
- 1.3.2.** Service Provider shall take reasonable measures to:
 - (a) Identify all reasonably foreseeable internal and external risks to the Personal Information in its possession or under its control;
 - (b) Establish and maintain appropriate safeguards against the risk identified;
 - (c) Regularly verify that the safeguards are effectively implemented;
 - (d) Ensure that the safeguards are continually updated in response to new risks or deficiencies in previously implemented safeguards; and
 - (e) Shall notify Kumkani Mhlontlo Local Municipality of the risks identified and the safeguards established and implemented from time to time.
- 1.3.3.** Service Provider shall:
 - (a) Have due regard to generally accepted information security practices and processes which may apply to it;

- (b) Comply with Kumkani Mhlontlo Local Municipality information security practices and procedures and applicable industry or professional rules and regulations, of which Kumkani Mhlontlo Local Municipality undertakes to keep Service Provider informed from time to time; and
- (c) Within five (5) business days of a request from Kumkani Mhlontlo Local Municipality, Service Provider shall provide to Kumkani Mhlontlo Local Municipality a written explanation and full details of the appropriate technical and organisational measures taken by or on behalf of Service Provider to demonstrate and ensure compliance with this clause.

1.4. Service Provider's general obligations with regards to Personal Information

1.4.1. In addition to the other obligations set out in this clause, Service Provider shall:

- (a) Take reasonable steps to ensure the reliability of any of its employees who have access to the Personal Information;
- (b) Limit access to the Personal Information only to those employees who need to know to enable Service Provider to perform the services and ensure that employees used by Service Provider to provide the Services have undergone training in the care and handling of the Personal Information;
- (c) Deal promptly and properly with all reasonable inquiries from Kumkani Mhlontlo Local Municipality relating to its Processing of the Personal Information and provide to Kumkani Mhlontlo Local Municipality copies of the Personal Information in the format reasonably specified by Kumkani Mhlontlo Local Municipality;
- (d) Promptly inform Kumkani Mhlontlo Local Municipality of its inability to comply with Kumkani Mhlontlo Local Municipality instructions and this clause, in which case Kumkani Mhlontlo Local Municipality is entitled to suspend the processing of Personal Information and/or terminate this Agreement;
- (e) Provide Kumkani Mhlontlo Local Municipality with full co-operation and assistance in relation to any requests for access or correction or complaints made by Data Subjects; and
- (f) At the request of Kumkani Mhlontlo Local Municipality or any regulatory body, submit its Personal Information Processing facilities for audit of the Processing activities covered by this Agreement.

1.5. Notifications

1.5.1. Service Provider must notify Kumkani Mhlontlo Local Municipality in writing:

- (a) Within 1 (one) business day or otherwise as soon as reasonably possible if any Personal Information has been or may reasonably believe to have been accessed or acquired by an unauthorised person or if a breach has occurred with reference to its use of the Personal Information under this Agreement. The notification must provide sufficient information to allow affected Data Subjects to take measures against the potential consequences of the compromise, including, if known to Service Provider, the identity of the unauthorised person who may have accessed or acquired the Personal Information;

- (b) Within 3 (three) business days of receipt thereof, of any request for access to or correction of the Personal Information or complaints received by Service Provider relating to Kumkani Mhlontlo Local Municipality obligations in terms of POPIA and provide Kumkani Mhlontlo Local Municipality with full details of such request or complaint; and
- (c) Promptly of any legally binding request for disclosure of Personal Information or any other notice or communication which relates to the Processing of the Personal Information from any supervisory or governmental body.

1.6. Return or destruction of Personal Information

Upon termination of this Agreement or upon request by Kumkani Mhlontlo Local Municipality , Service Provider shall return any material containing, pertaining or relating to the Personal Information disclosed pursuant to this Agreement to Kumkani Mhlontlo Local Municipality . Alternatively, Service Provider shall, at the instance of Kumkani Mhlontlo Local Municipality , destroy such material and shall certify to Kumkani Mhlontlo Local Municipality that it has done so, unless the law prohibits Service Provider from doing so. In applying this destruction alternative, the Service Provider shall provide Kumkani Mhlontlo Local Municipality with the Certificate of Destruction to confirm that the destruction was done in a manner that the Personal Information cannot be reconstructed to its original format. In that case, Service Provider warrants that it will guarantee the confidentiality of the Personal Information and will not actively process the Personal Information any further.

1.7. Warranties

Service Provider warrants that in addition to the warranties stated in the rest of this Agreement, it shall comply with all regulatory and statutory requirements which impact on or relate to Service Provider and the Services, including, but not limited to, POPIA.

1.8. Indemnities

Service Provider hereby indemnifies and holds harmless Kumkani Mhlontlo Local Municipality from any and all penalties, claims, loss or damage arising from any claim or action brought against Kumkani Mhlontlo Local Municipality and arising from or due to Service Provider's breach of its information protection obligations set out in this clause.

1.9. Ownership of Information

- 1.9.1.** Service Provider acknowledges and agrees that Kumkani Mhlontlo Local Municipality retains all right, title and interest in and to the Personal Information.
- 1.9.2.** Service Provider shall not possess or assert any lien or other right against or to such Personal Information and no such Personal Information shall be sold, assigned, leased or otherwise disposed of to third parties by Service Provider or commercially exploited by or on behalf of Service Provider or its employees.
